



# Youth Committee Members Application

## Montana USBC Youth

***With this application, you will be applying for one of the nine Montana USBC Youth Committee positions representing the bowling youth of Montana. All Committee Member terms are two (2) years. The duties of Committee Members are as follow:***

1. Attend the two required yearly meetings of the MUSBC association;
2. May be required to attend committee meetings at other times;
3. Elect the Committee Chairperson and Recording Secretary annually, from the committee membership;
4. Recruit nominees for the Committee membership to be forwarded to the MUSBC Nominating Committee;
5. Vote to fill a director vacancy on the MUSBC Board if the director was elected by the Youth Delegates and officers and directors holding youth membership;
6. Develop eligibility requirements for board members representing the youth to be approved by the delegates representing adult membership, Youth Delegates and board;
7. Develop eligibility requirements for the youth committee, subject to approval of the Youth delegates and officers and directors who hold youth membership;
8. Recommend you dues, to be approved by the board;
9. Monitor, promote, review and recommend youth programs conducted by the association;
10. Vote and/or act on all actions brought before the Committee;
11. Assist with the annual Youth State Championships and YBC Tournaments.

***Additionally, the duties of the MUSBC Youth District Directors include:***

1. Serve on the MUSBC Board as Youth Representatives and serve on committees needing youth representation;
2. Act as liaison between the MUSBC Board, the Youth Committee, and all youth activities;
3. Commit to travel in your district throughout the year, assisting local associations as necessary;
4. Communicate by written correspondence, telephone, e-mail and personal meetings with the associations in their district;
5. Help the Youth Committee Chairperson in obtaining high award forms that are past due.

***Qualifications:***

1. A candidate must be at least 14 years of age, a current member of MUSBC, a resident of Montana, and reside in the District they will represent if also running for a Board of Direction position.
2. A candidate running for a Board of Director position should have experience as an officer or director in a Montana state bowling organization (either at the state or local level).
3. Submit a completed application for the the position they are seeking.

***YOUTH COMMITTEE MEMBERS ARE ELECTED FOR TWO-YEAR TERMS AS FOLLOWS:***

**5 youth committee members will be elected in the even years and 4 youth committee members will be elected in the odd years.**

***THERE MUST BE AT LEAST ONE YOUTH COMMITTEE MEMBER FROM EACH DISTRICT AT ALL TIMES IN ORDER TO MAINTAIN YOUTH DISTRICT DIRECTOR REPRESENTATION TO THE MUSBC BOARD OF DIRECTORS.***
